

Tiwi Land Council Clan Group Meetings and Trustee Elections

Tiwi Land Council (TLC) elections will be held for Trustees at the following venues on the following dates –

Tuesday 20 June - Jikilaruwu (Tikilaru) at Mantiyupwi Motel

Wednesday 21 June – Wurankuwu (Ranku) at Mantiyupwi Motel

Thursday 22 June – Yimpinari at Milikapiti Sports Hall

Friday 23 June – Wulirankuwu at Milikapiti Sports Hall

Monday 26 June – Munupi at Munupi Sports Club

Tuesday 27 June – Mantiyupwi at Mantiyupwi Motel

Wednesday 28 June – Malawu at Mantiyupwi Motel

Thursday 29 June - Mirrikawuyanga at Mantiyupwi Motel

Officers from the Northern Territory Electoral Commission (NTEC) will be receiving Nominations for the positions from 9am until 11am on the day of each election (as above). If more than one (1) nomination is received an election will be held. Voting will take place at the venues listed above from 11:30am until 2:00pm. At the close of voting the votes will be counted and the results will be declared.

To be eligible to nominate for the Trustee position you must satisfy the following –

- Be at least 18 years of age,
- Be on the relevant Clan Group register. TLC Anthropologists will be present with current register (additions to the register close at 11am),
- To be eligible under s29 of ALRA
- Present the nomination signed by two (2) eligible Clan members, at the time and place as above.

To be eligible to vote for the Trustee position you must satisfy the following –

- Be at least 18 years of age,
- Be on the relevant Clan Group register. TLC Anthropologists will be present with current register (additions to the register close at 11am),
- Be present at the time and place as above

Tiwi Land Council Clan Group Meetings and Trustee Elections

Paraphrased s29 follows:

You are not eligible to be a member of the Tiwi Land Council if:

1. You are convicted of an offence (not involving dishonesty) and sentenced to a period of imprisonment of 12 months or more.
2. You are convicted of an offence involving dishonesty and are sentenced to a period of imprisonment of 3 months or more.
3. You are convicted of two or more offences and you:
 - a. Are required to serve a term of imprisonment of 12 months or more; or
 - b. Would have been required to serve a term of imprisonment of 12 months or more if the sentence had not been suspended.
4. You are convicted of two or more offences involving dishonesty and you:
 - a. Are required to serve a term of imprisonment of three months or more; or
 - b. Would have been required to serve a term of imprisonment of 12 months or more if the sentence had not been suspended.

If you fall into one of the categories listed above, you are not eligible to be a member of the Tiwi Land Council for:

- A. 2 years beginning on the day that you were released from prison if you were sentenced to spend time in prison.
- B. 2 years beginning on the day that you were convicted if you did not serve a term of imprisonment.
